DISCUSS AND/OR APPROVE CONDITIONAL USE PERMIT, SYDNEY BROOKS & DANA HOWARD, Address E4354 Stecks Rd., parcel number 12-23-43-2: Sydney Brooks provided an overview of their business plan operating a wedding barn/event center. A letter was read in opposition of the business from Steve and Abagail Bitter; Peggy Krause commented on the preservation of the barn built in the 1900's and the growing neighborhood over the years; discussion was held on width of the road and pot holes due to increase traffic, parking, noise. The barn was not inspected during the process of the remodeling. A historical preservation cannot be zoned commercial. Postponed until next month's meeting.

DISCUSS TOWN WIDE GARBAGE COLLECTION FOR THE TOWN OF LIND: Chairman Gall reported presently there are 3 different garbage collectors in the township. By having 1 garbage collector for the township, advantages could result in cheaper cost; less garbage on the roadside; less wear and tear on the town roads. Postponed until next month's meeting.
