The next Planning Commission meeting will be held Tuesday, July 6th, 2021 at 7 p.m. **UPDATE ON THE CONDITIONAL USE PERMIT, SYDNEY BROOKS & DANA HOWARD**, *Address E4354 Stecks Rd., parcel number 12-23-43-2:* Waupaca County Zoning meeting on the CUP for this property is being held Tuesday, June 22, 2021 at 1:30 p.m. Brooks/Howard are requesting to be completely for farm use. By requesting this, Weyauwega Fire Department would be solely responsible if any type of fire hazard occurred.

DISCUSS TOWN WIDE GARBAGE COLLECTION FOR THE TOWN OF LIND: Harper's representative Nick informed the Town Board there would be a minimum of a 5-year contract with capped price. Discussion was held on farm service charges and opting in and out of the service. **DISCUSS AND/OR APPROVED LAND LEASE AGREEMENT FOR LOCATION OF TOWER:** Chairman Gall report an agreement has been signed. Concerns were voiced about Waupaca On Line would be the only entity on the tower for the first 2 years.
