- Meeting called to order at 6:00 p.m.
- Open Meeting Statement read.
- Pledge of Allegiance done.
- Roll call: K. Nickel, T. Stearns, C. Hardy, C. McCoy, K. Barrows all present. Public attendance per sign in sheets (7 per sign in book).
- Approved Agenda: Motion by Supervisor II Hardy, seconded by Supervisor I Stearns to approve the agenda as printed; motion passed unanimously by voice vote.
- Public Input/Comments: None
- Approve or Amend Minutes: Town Board Meeting of September 8th, 2025: Motion by Chairperson Nickel, seconded by Supervisor II Hardy to approve the minutes as presented; motion passed unanimously by voice vote.
- Treasurer's Report: Treasurer Barrows reviewed monthly bank accounts.
- Clerk's Report:
 - Bills and Receipts: Supervisor II Hardy questioned the amount of per diems being paid out and having the complete board attend these meetings. Discussion was held and the board will appoint 1-2 people to attend upcoming meetings except for Wisconsin Towns Association quarterly meetings in which it is beneficial for the whole board to attend. Motion by Chairperson Nickel, seconded by Supervisor I Stearns to approve the adjustment to per diems going forward. Clerk McCoy requested approval of payment in the amount of \$40,898.93 which includes IRS payment of \$1,057.54. This payment was not included in the check spreadsheet. It was moved by Chair Nickel, seconded by Supervisor I Stearns to approve receipt of \$40,898.93. Motion passed unanimously by voice vote. American Asphalt invoice has been received. The ARIP payment is in progress. Chairperson Nickel would like to send payment to American Asphalt as soon as the ACH payment from the State is received to avoid having American Asphalt to wait another month for payment. Total amount due is \$406,227.25, 90% or \$365,604.53 is paid by the State and the Town's share of \$40,622.72. Motion by Chairperson Nickel, seconded by Supervisor I Stearns to approve payment once the ACH payment has been received. Motion passed unanimously by voice vote.
 - Set date for November Public Hearing of 2026 Budget, Meeting of the Electors. The meetings will be held on Monday, November 10th, 2025, with the Town Board meeting immediately following.
- Land Planning Commission meeting: No October meeting was held.
 - Discuss and/or approve Planning Commission Application Dawn Hardy Reith. The application had been reviewed. Motion was made by Chairperson Nickel, seconded by

Supervisor I Stearns to approve Planning Commission Application for Dawn Hardy Reith. She is replacing Steve Gall on the Board. Motion carried with Supervisor II Hardy abstaining.

- Oral Report from County Board Supervisors meeting: Supervisor II Hardy reported 2026 budget has been balanced. The County needs to prepare a 5-year plan moving forward. Next year there will be a short fall, and cuts will have to be made.
